1. PLEDGE TO THE FLAG

President Marlyn Stauffer called the August 3 2015 regular meeting of the governing body to order at 7:00 p.m. and led the pledge to the flag.

a) Mayor Jim Sanders performed the "Oath of Office" for Councilwoman Amy Levault who was appointed to fill the position left by Councilman Wilson Heltzel who resigned July 6, 2015.

a) Councilwoman Loeffler made the <u>motion</u> to nominate Councilwoman LeVault for the position of President Pro Tem, Councilwoman Roser seconded and the motion passed 5-0.

a) Councilwoman Loeffler made the <u>motion</u> to approve the July 6, 2015 Minutes, Councilwoman Roser seconded and the motion passed 5-0.

- a) Resident Frank Altland asked about the Grass issue at 15 Hanover Street. Borough Solicitor discussed the process of applying a lien on the property and expenses for mowing. Bank has posted their name on property so the Borough will have the Zoning Officer send notice of Ordinance Violation.

Councilwoman LeVault seconded and the motion passed 5-0. Solicitor will draft an amendment to the Ordinance.
- c) 10 Burns Road Zoning Officer will send notice to owners that property will require a Farmette Use to raise chickens on property.
